- 2. In the event that the Vendor wishes to place a reserve on a lot, the amount must be specified on the entry form (or before 9:30 am on day of sale)
- 3. All purchasers and vendors are deemed to have full knowledge of the "LAA Conditions Of Sale" and purchasers to have heard and understood the Auctioneer's description of the lot.
- 4. The Auctioneer may refuse, without giving a reason to accept either entries or bids.

- 6. The highest bidder shall be the purchaser and in the event of a dispute the lot shall be reoffered.
- 7. Neither the Vendor nor the Purchaser of a lot shall have any remedy against the Auctioneer in respect of a lot. The Auctioneer acts only as an agent inviting bids for the lot, but will supply names and addresses of principals on request by either in the event of a dispute.
